The Special Meeting of the Hamilton Township Board of Trustees was called to order at 6:30 p.m., by Chairman Chris Hann.

Purpose of the meeting was to discuss the Fire Department's promotional procedure and review the associated documents - prepared by former Chief Hafey, - prepared by Captain Thomas Ferrell.

Captain Ferrell presented the document that he had prepared, at the Chief's request, outlining the requirements that need to be met in order to apply for a promotion to captain or lieutenant at the Hamilton Township Fire Department. In reviewing the document, the following changes were decided upon in the lieutenant qualifications, in Ferrell's document.

Item #1 – Add statement "shall not have a break in service of more than one year".

Trustee Hann expressed his concern that Fire Fighter Riffle would not be able to apply because he had left the department in late 2022 and been rehired in early 2023. This employee had nine years of service prior to the resignation and should be allowed to enter his name into the pool.

Trustee Blackstone disagreed, stating that this was not fair to the employees who chose not to seek employment elsewhere. This Fire Fighter had agreed to return with no seniority and should not be included in the process. He was a lateral hire and according to the contract, he was not eligible to apply. Hann stated that it was not in the contract and this had been approved by the township attorney. Trustee Armstrong agreed with Hann that Riffle should be allowed in.

Blackstone stated that he considered this unjust to the other applicants but had no choice in the matter, due to the other two trustees being in favor of Riffle's inclusion. He was only one vote.

Item #4 – Remove item 4, containing the statement "Shall not be on probation for any reason".

There was a discussion regarding the removal of this statement and why. Trustee Blackstone was of the opinion that it needed to remain. Trustee Hann and Armstrong agreed with the removal. Ferrell was instructed to have the document updated by June 19, 2023 and distributed to the Board for approval.
