HAMILTON TOWNSHIP FIRE DEPARTMENT

Regarding miscellaneous Hamilton Township Fire Department matters, Chief Rosenberger informed the Board of his recent Activities – met with BN4 CFD; attended meeting with Mark Tyler, Hamilton Local Schools, discussed relationship/expectations.

Discussed installing infra-red signal activators for station 172 with Greg Thomas, Franklin County Engineer's office. Plan to have Danbert Electric to quote. Thomas stated that if the township pays for the expense of the work being done, and put on letterhead, Franklin County would work on light placement, eliminating having to hire a contractor along with licenses and permits. Fiscal Officer requested quotes before this work is approved, this was not a budgeted item.

M-174 to Rush Truck for repair estimate, needs engine oil cooling assembly, oil filter kit, oil pan w/stiffener rail, rear crankshaft and seal. Cost \$7,524.76. Still waiting on a quote from Horton for interior gauges and mounts. M-172 being repaired at Kreiger. Vibrations in braking system, after inspection, brakes, cailpers and rotors are being replaced. Cost \$4,385.43. Left strut also found to be worn, cost to repair is \$1,149.38. Issues found with front bumper on M-171. The brackets that hold the bumper to the frame are cracked and loose. Rusty's repaired for now to get the medic back in service. Chief to contact Horton regarding possible warranty replacement and reimbursement for labor cost to repair.

All American to be onsite next week to perform pump testing. Citizens First Fire Training to perform service on rescue tools.

Contacted Auston Gootee, he wants to start working part-time again after a long break. He has signed up for shifts in January 2024. Brody Dille has also signed up for several shifts in January. Two applications received for part-time employment. Lt. Mango is setting up physical agility testing.

E-171 is set for inspection and warranty repairs. All American to perform. Hose dryer is repaired. Turn out gear demos from several vendors scheduled. Firefighter Barkley to apply for FEMA Grant to possibly fund turn out gear replacement. Department voted to add Carhartt hooded sweatshirt to the approved uniform items. This replaces the 5.11 job shirt now being worn.

Waiting on quotes from Byers Chevrolet for a replacement for Chief 171 vehicle. There are two suitable vehicles on the state bid, the Chevrolet Tahoe – V8 and the Ford Explorer V-6. Trustee Hann stated that he is a no to the Ford. No timeline for replacement until quotes are reviewed.

Chief is still working on special duty contract for events. Hann cautioned that no contract is to be signed or agreed to without Board approval. Chief discussed his "Topic of the Month," smoke detectors. He attended several meetings including

FCFCA, starting a Metro Fire and EMS Peer Team. Touring several local businesses. Narcan leave behind program, anyone requesting Narcan can contact Tom Ferrell. Annual Stop the Bleed on May 23, 2024, free training to the public. Community Paramedic program has 32 patients participating. Adding 3-5 new patients per month.

Chief Rosenberger discussed refining hiring procedures. This includes the procedure for full-time and part-time fire employees. He would like a more structured approach. He discussed hiring basic EMT's that are not paramedics with no experience. The Board discussed the impact of this decision on the taxpayers that we serve. Fire Department is structuring and preparing a formal process for eligibility on the promotion list. This includes a clear definition of who is to ride out of classification. This will be approved by the Board before implementation. Met with medical director, looking forward to continuing partnership.
