This development of Younkin & Wilburn will consist of 1000 single family homes, apartments and condominiums (townhouses). Pricing ranging from 290,000 to 500,000 per single family home. Apartments to lease from !400 - \$4000 per month. Warner property at the NW corner of Rathmell & Lockbourne will be mixed-use containing both office & retail space.
