HAMILTON TOWNSHIP FIRE DEPARTMENT

Regarding miscellaneous Hamilton Township Fire Department matters, Chief Shillingburg informed the Board of the following: M171 at Krieger Ford for PM & brakes; flac jacket style has been chosen, made by Spartan. All medics are currently trying the sample on to make sure they fit. Approximate cost of \$6,200.00, has been budgeted; Fire Department met with residents of Enchanted Acres regarding the explosion and fire that injured two residents. Chief is meeting with inspectors to determine a cause and report this back to the residents; March 12th, the Fire Department is to return to Enchanted Acres for blood pressure tests, sheriff representatives to attend; and the Chief is trying to obtain donated CO detectors and smoke detectors for residents that need them.

WHEREAS, the Board of Trustees (the “Board”) of Hamilton Township, Franklin County, Ohio (the “Township”), has determined the public safety and welfare would be served by the following parking regulations; and,

WHEREAS, the State of Ohio has granted townships the authority to pass resolutions regulating the parking of vehicles on township roads pursuant to Ohio Revised Code (O.R.C.) Section 505.17; and,

WHEREAS, on or around April 25, 2018, the Board adopted Resolution No. 2018-92, adopting and enacting parking regulations;

WHEREAS, the Board desires to supersede and replace Resolution No. 2018-92 in its entirety; and

WHEREAS, the regulation does not conflict with the Uniform Traffic Act, and is applicable only to the unincorporated areas of the Township;

THEREFORE, BE IT RESOLVED by the Board of Trustees of Hamilton Township, Franklin County, that the following Resolution be, and it hereby is

adopted, which said Resolution, upon its effective date, shall supersede and replace Resolution 2018-92 in its entirety:

Section 1. No person shall stop, stand, or park any vehicle along the entirety of the east side of Service Drive, a Hamilton Township road, which is located in the unincorporated area of the Township, between Secrest Avenue and Edgeview Road, including the right-of-way.

(2020-61) RESOLUTION AMENDING RESOLUTION NO. 2018-92 IN ITS ENTIRETY AND ENACTING REGULATIONS FOR THE PARKING OF VEHICLES ON A DESIGNATED STREET AND RIGHT-OF-WAY IN HAMILTON TOWNSHIP, FRANKLIN COUNTY, OHIO CONTINUED

Section 2. Owners of vehicles parked in violation of parking regulations enacted by this Resolution will be notified by having a parking ticket handed to the vehicle operator by the Franklin County Sheriff's Office in a manner apparent to the operator of the vehicle and/or receipt of a summons from the Franklin County Municipal Court Clerk of Court. The ticket to be used pursuant to this Resolution shall be the "Ohio Uniform Traffic Ticket."

Section 3. Pursuant to O.R.C. Section 505.17(E), parking infractions shall be considered criminal offenses and a person who commits such a violation shall be guilty of a minor misdemeanor.

Section 4. Pursuant to O.R.C. Section 505.17(D), the Board or its designated agent may order into storage any vehicle parked in violation of these regulations. The owner or any lienholder of a vehicle ordered into storage may claim the vehicle upon presentation of proof of ownership, which may be evidenced by a certificate of title to the vehicle, and payment of all expenses, charges, and fines incurred as a result of the parking violation and removal and storage of the vehicle.

Section 5. For each violation of Section 1 of these parking regulations, the fine for a first violation shall be \$65.00; the fine for a second violation shall be \$90.00; and the fine for a third or more violations shall be \$100.00. Fines may be paid in person at the Franklin County Municipal Court Clerk of Court during business hours or mailed to 375 South High Street, Columbus, Ohio, 43215.

Section 6. These regulations are subject to the limitations, restrictions, and exceptions in O.R.C. Chapter 505, Sections 4511.01 through 4511.76, and Sections 4513.02 through 4513.37.

Section 7. The parking areas regulated as stated above shall be designated by the installation of traffic control devices conforming to O.R.C. Section 4511.09. Vehicles and owners may be exempt from certain restrictions created by this Resolution on the holidays enumerated in O.R.C. Section 511.10 and further specified in O.R.C. Section 1.14.

Section 8. The Township Fiscal Officer is directed to post these regulations in five (5) conspicuous public places in the Township for thirty (30) days and publish the same in a newspaper of general circulation in the Township once a week for three (3) consecutive weeks.

Section 9. It is hereby found and determined that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in an open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal action took place in meetings open to the public, in compliance with all legal requirements, including O.R.C. Section 121.22.

Section 10. This Resolution shall take effect at the earliest date permitted by law.

WHEREAS, the State of Ohio has granted townships the authority to pass resolutions regulating the parking of vehicles on township roads pursuant to Ohio Revised Code (O.R.C.) Section 505.17; and,

WHEREAS, the regulation does not conflict with the Uniform Traffic Act, and is applicable only to the unincorporated areas of the Township;

Section 2. Owners of vehicles parked in violation of parking regulations enacted by this Resolution will be notified by having a parking ticket handed to the vehicle operator by the Franklin County Sheriff's Office in a manner apparent to the operator of the vehicle and/or receipt of a summons from the Franklin County Municipal Court Clerk of Court. The ticket to be used pursuant to this Resolution shall be the "Ohio Uniform Traffic Ticket."

Section 3. Pursuant to O.R.C. Section 505.17(E), parking infractions shall be considered criminal offenses and a person who commits such a violation shall be guilty of a minor misdemeanor.

Section 4. Pursuant to O.R.C. Section 505.17(D), the Board or its designated agent may order into storage any vehicle parked in violation of these regulations. Regarding miscellaneous Hamilton Township Fire Department matters, Chief Shillingburg informed the Board of the following: all equipment is running; first virus exposure is still at home waiting on test results since March 17th; Riffle on light duty with shoulder injury, presently on Physical Therapy; Nader has been off sick since March 16th; and due to the pandemic, the township attorney has determined that the part time personnel can work more than the 1500 hour limit.

The Board instructed Chief Shillingburg to immediately discontinue the scheduling of a full-time township firefighter to fill a 6th open shift position at Station 171. The 6th slot is to be filled with a part-time firefighter only. Acceptable staffing is 5, 7 or 8 firefighters at station 171 and 3 firefighters at station 172. This is to keep overtime to a minimum. No exceptions.

Discussion was held regarding the need to hire full-time firefighters. Board is considering interviewing both internal and external candidates for the open positions.

Discussion was also held regarding the recently announced Community Assistance Program, publicized by the Hamilton Township Fire Department. The Board was not asked for approval to sponsor this program through Hamilton Township's Fire Department, nor was permission granted to post the details on the Township's website. Although the Board of Trustees would not want to put the fire department employees or taxpayers at risk with this type of activity during a pandemic, it was decided to allow the program to continue for the time being. Chief Shillingburg is asked to bring this type of request to the Board in the future.
