The Special Meeting of the Hamilton Township Board of Trustees was called to order at 7:30 p.m. by Chairman Chris Hann.

Members Present: Blackstone yea Armstrong yea Hann yea

Visitors Present: Gwen Young, Marvin Young

Trustee Hann opened the meeting by stating that the purpose was to prepare documentation for presentation to township residents describing the township's need for the replacement of two expiring operating levies.

The Board of Trustees was concerned about recent posts on social media regarding the need for levies that did not contain accurate information.

One particular post from a resident of Hamilton Meadows mistakenly stated the levy was being placed on the ballot to provide additional services to the new development at Warner farms in Obetz. Trustee Hann stated that he had left a message for the resident, explaining that this is incorrect, and received no response. However, the post was updated to reflect more correct information regarding the levy.

Trustees also stated that the spouse of an employee is posting derogatory comments to social media regarding the Board of Trustees. The board acknowledges that this is not something that they have control over, but noted residents are always encouraged to attend open board meetings to discuss any concerns.

The board discussed with Chief Shillingburg the issue of not having a ladder to reach the third floor of the apartments being built. Shillingburg stated that while the township does not have equipment that would reach the top floor, there were ladders belonging to neighboring departments that could be on the scene of a fire in a matter of minutes.

There was another issue of the taxes that are being collected through the TIF approved on the Warner property. The township has no representation on the CRA panel. To date, there is no plan in place to reimburse the township for the loss in revenue. However, this property has not been built out, so the impact on township Fire/EMS services is minimal.

The board noted that the previous fire chief had requested assistance in purchasing a ladder with the City of Obetz and they responded that we should rely upon mutual aid.

The board stated that they were in negotiations with the City of Obetz regarding potentially providing property to construct a new fire station. Nothing has been finalized to date.

Captain Edwards suggested that the township would benefit from keeping three medics in service at all times. This has not been possible due to staffing issues. Perhaps the board would consider adding three more medics in the future to accomplish this.

Trustees explained that adding staffing was not in the plans in the near future. The goal of the levy is to remain at the same level of service. If these levies did not pass, the township would face cuts.

Trustee Blackstone asked what could be done to keep the township equipment in the township and available for the residents. Edwards stated that he would push for the third medic to be classified as "Level One" for dispatching, meaning it would only leave the township for the most serious calls.

Township and reduce the runs to the City of Columbus. The fire chief stated he did not think this was possible.

The board discussed with the chief the impact of the new multi-family development on Rathmell Road in Columbus. The Chief stated that when an incident is reported, the closest available equipment would be dispatched. This could be Hamilton Township, if Columbus's equipment were not available (in-service).

Wade Edwards asked the board what they intended to do with his present position once he retired.

Trustee Hann asked Edwards when he intended to retire, he stated he would let the board know by May, he would be retired by summer 2023.

Trustees informed Edwards that per the contract, it is the desire of the board to convert the EMS Coordinator job to an assistant chief position. Edwards asked who would do the community paramedicine duties. The board stated that the unit captains have all been trained to do this function. It is the board's intent to have the captains assume this duty. Edwards stated that of the three captains that were trained, one has resigned, one is not showing interest, but there is one captain extremely interested in the job. Edwards believes this position is a valuable public relations tool for the township and was disappointed that the township was not keeping it in its current capacity.

The board inquired on the status of the EMS Training class offered in partnership with Hamilton Local schools. Edwards stated that he currently has five students in the program. Of the five, one is planning to apply at Columbus Division of Fire, two are going to be nurses and only two are pursuing this as a career at some point. To date, the township has not been compensated for Edwards time by the board of education. Trustee Hann advised Edwards that he could continue this as a private contract with the school after he retires. The board does not plan to provide an instructor for the program in the future.

The board also advised Chief Shillingburg that no employee has been authorized by the board to function as chaplain for the fire department. It is the board's decision to use the chaplain services available through Franklin County Sheriff's Department in this capacity.

FRANKLN COUNTY SHERIFF'S DEPARTMENT

Regarding miscellaneous Franklin County Sheriff's Department matters, no run stats to report. Juvenile issues in Steeplechase, deputy is taking care of the situation. Deputy is beginning the enforcement of parking violations and abandoned vehicles in Hamilton Meadows sub-division. Drag racing off Rohr Road seems to have stopped, The business that owns the driveway that is being used has been instructed to erect a gate and fencing to restrict access to the property. Frequent red-light violations are being reported at the intersection of Rathmell and Lockbourne Roads. Sheriff car has been requested by the Board to watch the intersection in the early morning hours.

CITY OF COLUMBUS - DEREK ANDERSON AND ADAM SINGLESTEIN

Nexterra Energy was selected by the City of Columbus to construct a solar panel field on Parsons Avenue, near the water treatment facility. They were in attendance to explain the project and answer any questions/concerns regarding it from township residents. Columbus is committed to green projects as their climate action goals. This solar field will generate enough electricity to power 5000 residential homes for one full year. Power generated will only be used by the City of Columbus, not the Google Project. This field will be west of Hamilton Meadows and a north to south configuration with a tracker system that automatically moves the panels with the solar positioning. There should be no noise or reflection from the panels that would disturb the area. Construction has begun with site preparation and is expected to take 7 to 8 months to complete. Two emergency entrance/exits will be constructed adjoining township roads, one at Edgeview and another at Grenada Road in Hamilton Meadows. These are for emergency access only and will not be used for any in or out-going traffic. The primary access to the solar field will be off Parsons Avenue. Solar field will be landscaped with low growing vegetation and mowed twice per year, with the road frontage kept at 10" maximum height. There should be no danger of fire from vegetation. Surface water will be mitigated with four detention basins including ditches. Property will be landscaped on three sides with rows of trees, the only section not surrounded by trees would be the area between the solar field and the water treatment facility. The Board encourages any resident with questions or concerns to contact the township office.

HAMILTON TOWNSHIP FIRE DEPARTMENT

Regarding miscellaneous Hamilton Township Fire Department matters, Captain John Blankenship addressed the Board regarding a trade that he was involved in with firefighter Scott Johnson. Blankenship stated that on February 25, 2023, he worked a shift trade with Scott Johnson, in return Johnson was to work a shift on April 30, 2023.

HAMILTON TOWNSHIP FIRE DEPARTMENT CONTINUED

Blankenship stated that there was an on-going internal investigation regarding Johnson when the first trade occurred on February 25, 2023. Blankenship was told to go ahead and work the trade. Scott Johnson resigned from the fire department effective April 11, 2023, leaving him unable to fulfill his trade with Blankenship on April 30, 2023. Blankenship stated that two weeks ago, he was told not to use a sick day for April 30, 2023. Blankenship felt his integrity was being questioned, as he has been a long-time township employee who would not use a sick day in this manner. Blankenship asked if he could have the time off excused?

Chairman Hann asked Blankenship what he wanted the Board to do? The trades were an agreement between two employees and not covered by any part of the CBA. Blankenship stated that he would like to see a document composed and approved that outlines the trade procedure. Especially since two other fire department employees had encountered the same situation as him and been treated differently. Hann asked who these employees were and Blankenship stated Cantrell and Pullen. Hann asked Chief Shillingburg if he was aware of these incidents, Shillingburg stated "no". Hann stated that the Board was not going to get involved and if they had to get involved they would consider not allowing trading of shifts at all. Trustee Blackstone stated that he had a problem with the risk when employees did not complete the trades in a timely manner. This trade spanned over three months; many things can happen as time passes. Trustee Armstrong agreed, trades should be allowed but perhaps not over this amount of time span.

Hann asked Blankenship if he had contacted Scott Johnson since his departure from the department, he should ask Johnson to repay him the shift he worked for him. Blankenship stated that he had talked to Johnson on several occasions, but not about repayment of the time. Hann suggested that Blankenship contact Johnson and request payment. The only other option is to personally file a case with small claims court for repayment. Blankenship stated he would work his shift on April 30, 2023, the day he requested for trade.

Chief Shillingburg informed the Board of the following: E-172 has 50% wear on the brakes. The brakes have 12,166 miles on them. They will be rechecked in six weeks; siren repaired on M-173; kingpin issue on M-171 it is at Krieger Ford; he has six interviews for two open positions in the fire department. The delay in hiring is due to length of time to obtain BCI and driving abstracts; power cot has been delivered for the new medic; Lt. Cameron Lowe has requested permission to attend a Scott Air Pac technical class at Grandview fire department. The Board was in approval that he can attend at a cost of \$175.00; EMS will be provided to the Fortress Obetz on May 10th, baseball opening day; air show at Rickenbacker in June; Devono's has graciously donated time and material to repair the rust on the back fender of CH171 car; and the roof at 172 is still leaking, Chief to contact roofing companies to get estimates to replace this section immediately.
